SECOND NOTICE OF AVAILABILITY OF INTERVENOR FUNDS  
AND SCHEDULE FOR SUBMITTING FUNDING REQUESTS

(Issued November 30, 2016)

Cassadaga Wind LLC (Cassadaga) filed an application on June 16, 2016, seeking authority to build and operate a 126 megawatt (MW) wind energy project, including the installation and operation of up to 62 wind turbines, together with associated collection lines (below grade and overhead), access roads, meteorological towers, operation and maintenance building, collection and point of interconnect substations, and related facilities (the Project). The Project is proposed to be located in the Towns of Charlotte, Cherry Creek, Arkwright, and Stockton in Chautauqua County, and would interconnect to the state's electrical grid along the Dunkirk-Moon 115 kV transmission line.

On November 28, 2016, the Chair of the New York State Board on Electric Generation Siting and the Environment (Siting Board) determined that the application of Cassadaga Wind LLC is compliant with the Siting Board's filing requirements.

**TAKE NOTICE** that, pursuant to Public Service Law (PSL) §164(6), an intervenor fund of \$126,000 has been established for this proceeding. An initial notice issued on June 2, 2016 established June 29, 2016 as the first deadline for requests for intervenor funds. That notice is available on the Siting Board website, <http://www.dps.ny.gov/SitingBoard>. One joint request for funds was received on June 29, 2016 from the towns of

Arkwright, Charlotte, and Cherry Creek (the Joint Towns), and is being considered. This notice sets a schedule for a second round of funding requests. The Joint Towns need not refile to request application-phase intervenor funds, but may amend or modify their request for funds, should they so desire.

Eligible municipal and local parties may request funds by submitting the requests to the Examiners, Administrative Law Judges Kevin Casutto ([Kevin.Casutto@dps.ny.gov](mailto:Kevin.Casutto@dps.ny.gov)) and Dakin D. Lecakes ([Dakin.Lecakes@dps.ny.gov](mailto:Dakin.Lecakes@dps.ny.gov)) of the Department of Public Service and Administrative Law Judge P. Nicholas Garlick ([Nicholas.Garlick@dec.ny.gov](mailto:Nicholas.Garlick@dec.ny.gov)) of the Department of Environmental Conservation. **Requests for funds must be submitted by the close of business, Tuesday, December 20, 2016.** Parties intending to request intervener funding must use the "RFIF Form" available on the New York State Board on Electric Generation Siting and the Environment's (Siting Board) web page at <http://www.dps.ny.gov/SitingBoard> (please follow the "Forms" link on the left side of the page).
